

# 二、申請資格 Application Eligibility

申請人須符合「外國學生來臺就學辦法」規定:

An applicant must satisfy the requirements set by the "Regulations Regarding International Students Undertaking Studies in Taiwan" (Regulations):

- 1. 具外國國籍且未曾具有中華民國國籍,符合下列規定者,得依本辦法規定申請入學: A person of foreign nationality who has never held Republic of China ("R.O.C.") nationality and who meets the following requirements is permitted to apply for admission to an educational institution, in accordance with the provisions of these Regulations:
  - (1)未曾以僑生身分在臺就學。

The person has never undertaken studies in Taiwan as an overseas Chinese student.

(2)未於申請入學當學年度依僑生回國就學及輔導辦法經海外聯合招生委員會分發。 The person has not been given a placement in the current academic year by the University Entrance Committee for Overseas Chinese Students in accordance with the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan. (Article 2 of the Regulations).

- 2. 外國學生之國籍限東協十國、南亞六國及紐澳等新南向國家。 International students only include those from ten ASEAN nations, six nations from South Asia, and Australia and New Zealand.
- 3. 具外國國籍並符合下列規定,且最近連續居留海外六年以上者,亦得依本規定申請入學。(計算至2025年8月1日)。(外國學生來臺就學辦法第2條)

A person of foreign nationality who meets the following requirements and who in the immediate past has resided overseas continuously for at least six years is also permitted to apply for admission to an educational institution, in accordance with these Regulations. (as of August 1, 2025):

- (1). 申請時兼具中華民國國籍者,應自始未曾在臺設有戶籍。 A person who at the time of their application also holds dual R.O.C. nationality shall have never had household registration in Taiwan.
- (2). 申請前曾兼具中華民國國籍,於申請時已不具中華民國國籍者,應自內政部許可喪失中華民國國籍之日起至申請時已滿八年(計算至 2025 年 8 月 1 日)。 A person who before the time of their application also held dual R.O.C. nationality but no longer does at the time of their application shall have renounced their R.O.C. nationality with the approval of the Ministry of the Interior on a date at least eight full years before making their application. (as of August 1, 2025).
- (3). 前二款均應符合前項第一款及第二款規定。

A person referred to in either of the preceding two subparagraphs shall meet the requirements stipulated in Subparagraph 1 and Subparagraph 2 of the previous paragraph.

依教育合作協議,由外國政府、機構或學校遊薦來臺就學之外國國民,其自始未曾在臺設有戶籍者,經教育部核准,得不受前二項規定之限制。

According to education collaboration agreements, foreigners recommended by foreign governments, institutions, or schools to study in Taiwan who have never registered households in Taiwan are free from the preceding two paragraphs' restrictions, upon the approval from the Ministry of Education.

4. 具外國國籍,兼具香港或澳門永久居留資格,且未曾在臺設有戶籍,申請時於香港、澳門或海外連續居留滿 6 年以上者 (計算至 2025 年 8 月 1 日)。(外國學生來臺就學辦法第 3 條)

An applicant of foreign nationality, who is eligible for permanent residence in Hong Kong or Macao, who has never had household registration in Taiwan, and who at the time of their application has resided in Hong Kong, Macao, or elsewhere overseas continuously for at least six years may apply for admission in accordance with the provisions of these Regulations. (as of August 1, 2025). (Article 3 of the Regulations)

5. 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍,申請時已連續居留海外六年以上者(計算至2025年8月1日)。(外國學生來臺就學辦法第3條)

A person who was formerly from the Mainland Area and who has foreign nationality and has have never had household registration in Taiwan, and who at the time of their application has resided overseas continuously for at least six years may apply for admission to an educational institution, in accordance with the provisions of these Regulations. (as of August 1, 2025) (Article 3 of the Regulations).

上述所稱海外,指東協十國、南亞六國及紐澳等新南向國家或地區;所稱連續居留,指外國學生每曆年在國內停留期間合計未逾一百二十日。連續居留海外採計期間之起迄年度非屬完整曆年者,以各該年度之採計期間內在國內停留期間未逾一百二十日予以認定。但符合下列情形之一且具相關證明文件者,不在此限;其在國內停留期間,不併入海外居留期間計算:

The term overseas in the preceding subparagraphs denote new southbound nations or regions, including ten ASEAN countries, six South Asian countries, Australia, and New Zealand. The term consecutive residency denotes that a foreign student's stay in Taiwan does not exceed in total of 120 days per calendar year. If the beginning or the end of consecutive residency overseas does not fall within a complete calendar year, then the duration shall be counted according to the fact that the student does not exceed his/her stay of 120 days in Taiwan during the counted duration for the given year. This, however, does not apply to the following conditions, where appropriate documents of proof are provided. In such case, the residency length of stay shall not be counted toward his/her stay of overseas residency:

- (1). 就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。
  - The student attended an overseas youth training course organized by the Overseas Compatriot Affairs Council or a technical professional training program accredited by the Ministry of Education.
- (2). 就讀教育部核准得招收外國學生之各大專校院華語文中心,合計未滿二年。 The student spent a total period of less than two years undertaking Chinese language classes at a Chinese language center at a university or tertiary college which has Ministry of Education approval to recruit students overseas.
- (3). 交換學生,其交換期間合計未滿二年。
  The student spent a total period of less than two years in Taiwan as an exchange student.
- (4). 經中央目的事業主管機關許可來臺實習,實習期間合計未滿二年。 The student spent a total period of less than two years undertaking an internship that they came to Taiwan to undertake with the approval of the designated central competent authority.
- 6. 外國學生依上開規定申請來臺就學,以一次為限。(外國學生來臺就學辦法第 4 條) An international student applying to study at an educational institution in Taiwan in accordance with the provisions of the two previous articles is limited to only applying once. (Article 4 of the Regulations)
- 7. 外國學生須符合教育部採認之高級中等以上學校畢業,或具有與我國學制相當之同 等學力資格。

Foreign students must be at least a high school graduate from schools accredited by the Ministry of Education, or possess academic qualifications equivalent to the education system in Taiwan.

# 三、申請流程 Application Procedure

Please submit a copy of your passport or proof of nationality. If you have an Alien Resident Certificate, submit one copy of the certificate. If you have dual nationalities, possessing ROC nationality and other foreign nationality(-ies), as stated in Article 2 of the Regulations Regarding International Students Undertaking Studies in Taiwan, you need to submit entry/exit record over the past 6 years, an affidavit that you have not registered household in Taiwan, a document proving you have been approved of losing ROC nationality, or other proof documents.

(3). 學歷證明文件 1 份(中、英文以外之語文,加附由畢業學校或政府機關認可之中文或英文譯本為佳):

One diploma of highest education level and official transcripts (if the transcript is in a language other than Chinese or English, it is recommended that you attach an additional Chinese or English translation given by the school you graduated from or approved by the government):

- A. 高中(含)以上畢業學歷證明文件影本,至遲於註冊報到時繳交。 Copy(-ies) of your high school (or above) academic transcript(s). Submit it (them) no later than you enroll.
- B. 繳交由原修業學校提出之外國學校最高學歷或同等學歷證明文件,若本校對於申請文件認定有疑義時,得要求補繳經駐外使館處驗證之證明文件。

Submit your highest academic education record overseas or equivalent academic qualifications, provided by the school where you studied. If the University has doubts on the application documents, it has the right to ask the applicant to resubmit proof documents notarized by the embassies/official representative offices overseas.

C. 取得入學許可後,於辦理報到時,需繳交台灣駐外單位、代表處或其他 經外交部授權機構驗證之畢業證書(認證章正本及影本),始得註冊入學。 Upon receiving offer of admission, you are required to submit, at the check-in day, your graduate certificate (notarized copies) notarized by official outposts, representative offices, or agencies authorized by the Ministry of Foreign Affairs to be able to proceed with registration.

(4). 歷年成績單1份(中、英文以外之語文,加附由畢業學校或政府機關認可之中 文或英文譯本為佳):

Provide one academic transcript showing all the scores over the past years (if the transcript is in a language other than Chinese or English, it is recommended that you attach an additional Chinese or English translation given by the school you graduated from or approved by the government):

- A. 高中歷年成績單影本(至少含高中第1至第5學期之成績)。 Copy of high school transcript (including at least scores from semester 1 to semester 5 in high school).
- B. 本校對於申請文件認定有疑義時,得要求補繳經駐外使館處驗證之證明 文件。

If the University has doubts on the application documents, it has the right to ask you to resubmit proof documents notarized by the embassies/official representative offices overseas.

C. 取得入學許可後,於辦理報到時,需繳交台灣駐外單位、代表處或其他經外交部授權機構驗證之成績單(認證章正本及影本),始得註冊入學。 Upon receiving offer of admission, you are required to submit, at the check-in day, your transcript (notarized copies) notarized by official outposts, representative offices, or agencies authorized by the Ministry of Foreign Affairs to be able to proceed with registration.

#### (5). 語言證明文件:

# 四、甄審方式 Screening and Review

- 1. 評分方式: Evaluation method:
  - (1) 甄審成績:採為面試成績(40%)及書審資料成績(60%),擇優錄取。 Screening score: interview (40%) and document review (60%). Selection is based on merit.
  - (2) 面試係指 (A)指派面試委員親赴各國面試、(B)遠距視訊面試。 Interview Method:(A) Interview in person by interview commissioners (B) Online interview
  - (3) 經開班系審定通過不須參加視訊面試者,得直接進入推薦錄取名單。 The department may decide to skip interviews; in such case, the applicant may directly be recommended for admission.
- 2. 錄取標準: Acceptance Criteria
  - (1) 由本專班招生委員會依甄審總成績擇優錄取,餘列備取。依最終錄取結果,公 告最低錄取標準。

Students are to be admitted or put on waiting list according to their screening and interviews scores judged by the Admissions Committee. Lowest criteria standard will

be announced based on the actual admission results.

- (2) 正取生有缺額時,由備取生依序遞補至多到核定招生名額數為止。 Admission vacancies may be filled by students on the waiting list until reaching the required admission target.
- (3) 本校得視成績採不足額錄取,正取生錄取不足額時,不列備取生。
  The University reserves the right to accept fewer numbers of students than targeted based on scores. If the admitted number of students is far smaller than the admission target, there will be no places for waiting list.
- (4) 每班最終錄取學生人數**低於 25 名**時,不予開班。
  The program will not run unless there are more than 25 students enrolled.

When two or more students have the same screening and interview scores, they will be judged and compared with the following criteria, in sequential order:

The highest academic scores over the past few years.

The recruiting department will hold a screening and interview team meeting to discuss the matter, and will hold video meeting if necessary •

One original academic record or equivalent academic record (one original document notarized by ROC embassy/representative office or relevant offices; notarization is not necessary if the academic record document is issued by a Taiwanese school).

(3) **最高學歷歷年成績單正本 1 份**(經成績單授予學校所在地之中華民國駐外館 處或相關規定單位驗證正本 1 份;若成績單為臺灣學校所授予,則不需經由駐 外機構驗證)。

Original academic score transcript covering all semesters of the students highest academic qualification (one original document notarized by ROC embassy/representative office or relevant offices; notarization is not necessary if the academic record document is issued by a Taiwanese school).

- (4) 財力證明書: Financial statement
  - A. 最近 3 個月內經金融機構開具 (至少美金 1 千元),或政府、大專校院或 民間機構提供全額獎助學金之證明。

Provide a financial statement issued by a financial institution within the last 3 months (showing a balance of at least 1,000 USD), or provide proof of full scholarship issued by the government, the university, or private institutions.

B.申請學生財力證明,審核條件為:須經銀行等金融機構開立存款證明,財力證明不限活期存款或定期存款。財力證明若由本人名義開立,必須有銀行蓋章證明,若由父母親名義開立,則必須再加附公證證明文件,但若有政府、大專校院或民間機構提供全額獎助學金之證明者則免附。

Review criteria for the financial statement provided by the applicant student: The statement must be issued by a bank or a financial institution; the statement is not limited to demand deposit or certificate of deposit. If the statement is issued by the student, such statement must be stamped by the bank; if the statement if issued by the student's parents, such statement must be accompanied by a notarized document. No notarized document is necessary if the student can provide full scholarship statement issued by the government, university, or private institutions.

- (5) 健康檢查證明書: Health check statement:

Needs to be issued by a hospital within the past 6 months.

Can be provided after admission is confirmed and upon registration. Failure to provide a health check statement will see the applicant's admission being canceled. Students with unsatisfactory health status will be dealt with according to regulations such as the "Immigration Act" and "Regulations Governing Visiting, Residency, and Permanent Residency of Aliens".

Those deemed as violating such clause after investigation will have their admission qualification or student identification revoked.
- 5.外國學生註冊時,新生應檢附已投保自入境當日起至少 6 個月效期之醫療及傷害保險,在校生應檢附我國全民健康保險等相關保險證明文件。前項保險證明如為國外所核發者,應經駐外館處驗證。
  - Upon registration, new foreign students shall provide proof of medical and injury insurance covering at least six months from date of entry to Taiwan. Those already studying in school shall provide proof of insurance, such as Taiwan's National Health Insurance. If the aforementioned proof documents are issued by a foreign entity, they must be notarized by ROC embassies or representative offices.

Such case will be handled by the University according to regulations. Appeal cases cannot be anonymous. Anonymous cases will not be processed.

In case a difference arises between Chinese version brochure and English version brochure, the Chinese version of the admission brochure serves as final guidance. ### 國立勤益科技大學外國學生專班招生委員會組織規程 National Chin-Yi University of Technology Regulations on the Organization of International Student Program Admission Committee

108 年 6 月 3 日外國學生專班第1次招生委員會決議訂定

Formulated according to the resolutions passed by the International Student Program Admission Committee, 1st session on June 3, 2019

#### 第一條 Article 1

本校為配合教育部新南向政策及推動本校國際化,依據教育部發布「大學辦理招生規定審核作業要點」 特組織「國立勤益科技大學外國學生專班招生委員會」(以下簡稱本會),並訂定組織規程(以下簡稱本規程)。

The "International Student Program Admission Committee" (hereinafter the Committee) is organized according to the "Working Directions for the Reviews of University Admission Rules", published by the Ministry of Education, with a goal of supporting the Ministry of Education's New Southbound Policy and extending the University's international outreach. To this end, the following regulations are formulated (hereinafter the Regulations).

#### 第二條 Article 2

本會置主任委員一人,由校長擔任之,綜理會務;置副主任委員一人,由副校長擔任之,協助主任委員處理會務;置總幹事一人由國際事務處處長擔任之,秉承主任委員指示綜理本會招生事宜及交辦事項;並置委員至少三人,由相關單位主管、相關各系及代表組成。本會會議由主任委員視招生項目,召集相關委員為之。

The Committee shall have one Chairperson, assumed by the President of the University, who shall manage the affairs of the Committee. The Committee shall have one Vice-Chairperson, assumed by the Vice-President of the University, who shall assist the Chairperson manage the affairs of the Committee. The Committee shall have one Executive Secretary, assumed by the Director of the Office of International Affairs, who shall manage the admission affairs and other affairs as instructed by the Chairperson. In addition, the Committee shall have at least three committee members, comprised of head of relevant units, departments, and representatives. Meetings of the Committee, as well as relevant committee members, are to be convened by the Chairperson according to admission subjects.

#### 第三條 Article 3

本會遵照法令辦理招生事宜,其職責如下:

Admissions are carried out by the Committee according to the laws and regulations. The duties of the Committee include the following:

(一)審議招生簡章及有關招生事務章則、辦法。

To review admission brochures as well as admission guidelines and regulations.

(二)審議收支預算表,並決定人力及經費之分配運用。

To review balance sheets and budgets and decide on allocation of human resources and funding.

(三)訂定招生工作事項及日程。

To formulate tasks and schedules related to admissions.

(四)決定招生廣告之刊登事宜。

To decide on admission advertising.

(五)決定招生新生名額及錄取標準。

To decide on the number of new student intakes and admission criteria.

(六)辦理有關招生研究改進事項。

To carry out research tasks related to improving admissions.

(七)其他有關招生工作事宜。

To carry out other tasks related to admissions.

#### 第四條 Article 4

The organizational directions for each screening and interview team shall be drawn up by each unit separately.

#### 第八條 Article 8

Meetings may only begin upon the presence of more than 2/3 of Committee members who are obliged to be present. Resolutions may only be passed upon meeting the preceding criteria and with consent from more than 1/2 of attending members. A Committee member may delegate a proxy to attend meetings if he/she cannot attend, and thereby giving the power to vote to the proxy.

#### 第九條 Article 9



©Admission Stipend: 10,125 NTD will be given to freshmen that have completed registration in the first semester. Students who successfully pass all the subjects and the conduct grade in the last semester and conform to the school rules will get another 10,125 NTD in the second semester.

- ◎Tuition will be 100% waived for freshmen that have completed registration in the first semester. 新生完成註冊者,第一學期免學雜費。
- ⊚If students successfully pass all the subjects in the last semester and conform to the school rules, fees will be 100 waived for the second semester to the third semester after the examination of the committee board. If students haven't passed Language proficiency level 2 Test of Chinese as a Foreign Language (TOCFL) after the second semester, Tuition and Miscellaneous fees would not be waived, also would be expelled from school.

©If the time of registration by a foreign student has not exceeded 1/3 of the first semester, he/she shall be admitted to the University at the same semester. However, admission will be canceled if registration is overdue.

# for New Students of National Chin-Yi University of Technology

- 一、 入臺前簽證說明:以下為簽證辦理之原則,駐外館亦可能依情況調整更動。 Visa instructions before entering Taiwan: The following are the principles of visa processing, and the Embassy may adjust and change according to the situation.
  - 1. 持正式畢業證(明)書者:外館可核發居留簽證。
    With official certificate of graduation: Resident Visa may be issued by the Embassy.
  - 2. 持臨時畢業證(明)書者:外館可核發 60~180 天不等之停留簽證,後續必須申請延 簽或轉換居留簽證,費用約新臺幣 3500 元(含居留證辦理費用),學生需自行負擔。 如無法成功於臺灣轉換居留簽證者,需出境重新辦理居留簽證來臺,期間所發生之 費用由學生自行負擔。

With temporary certificate of graduation: 60-180-day Visitor Visa may be issued by the Embassy. You must apply for the extension or conversion of Residence Visa afterwards. The cost is about 3500 NTD (including ARC processing fee.) If you fail in changing Residence visa in Taiwan, you may take the risk of flying back to your country to reapply for Residence Visa to Taiwan. **All costs happened shall be afforded by yourself.** 

二、 臺灣防疫規定及說明:以下為目前防疫規定,因疫情變化不斷,學生來臺時依據我國 最新防疫管控政策規定辦理。

Regulation and Instructions of COVID-19 Prevention in Taiwan: The following are the current regulations of COVID-19 prevention. Due to the continuous changes of epidemic, students should follow the latest regulations when they come to Taiwan.

- 1. 學生接獲錄取通知後,請務必與學校保持聯繫,以確保簽證辦理流程及了解臺灣最新防疫規定。若因無法聯繫或程序錯誤致無法如期抵臺,後果由學生自負。 When you are admitted, please do keep in touch with School to ensure the procedures of visa application and get known about the latest regulations of prevention of COVID-19.
- 2. 入境後快篩陽性者須依政府規範,在固定時間或軟體上通報健康狀況,且不得離開檢疫處所之房間,且不可關閉手機或手機 GPS 訊號。
  - If Students have positive of COVID-19 rapid test, must report their health status on time or on software in accordance with government regulations, and must not leave the quarantine room, also must not turn off their mobile phones or mobile GPS signals.
- 3. 檢疫期間,學生須與本校同仁保持聯繫,不可中斷或無回應。 During the quarantine period, students must keep in touch with School.
- 4. 檢疫期間未遵守臺灣政府防疫規定者,最高處以新臺幣 100 萬罰款;另學校亦有校 規處罰。

During the quarantine period, those who fail to comply with the COVID-19 prevention regulations of the Taiwan government will **be fined up to NT\$1 million**. In addition, NCUT also have rules and penalties.
